Stakeholder Consultation Context

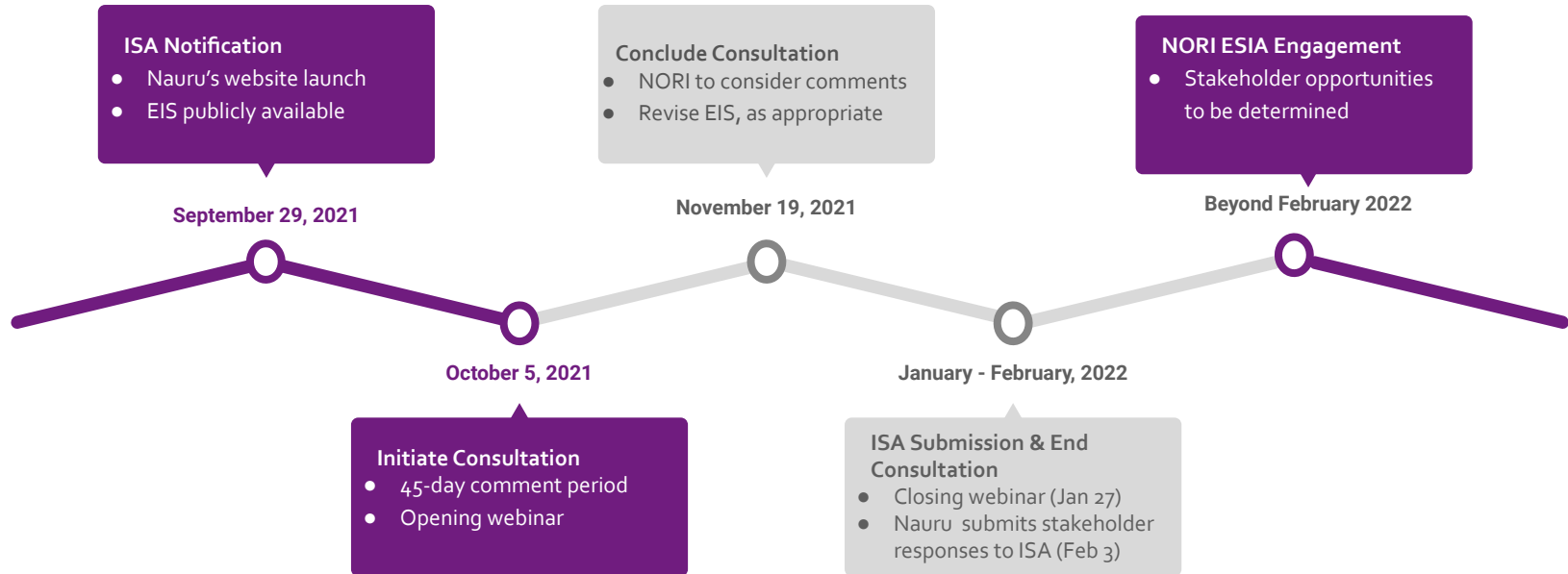
Today is focused on the Collector Test EIS, which is a component of NORI's larger ESIA process
